9 Pursuant to the foregoing Consent to Entry of Order, the evidence and records compiled and
10 contained in the file for KIEL T. GILLETTE and for good cause appearing, the Board on this 9th day of
11 November, 2000 enters the following Finding of Fact, Conclusions of Law and Board Order in the Matter
12 of Notice of Hearing 00-0017-PHR.

13 **FINDINGS OF FACT**

14 **I**

15 1. KIEL T. GILLETTE is the holder of Certificate of Registration Number 9347 issued by the
16 Arizona State Board of Pharmacy which permits the holder to practice pharmacy in the State of Arizona.

17 2. That on the 27th day of October, 2000, KIEL T. GILLETTE did enter into a Consent to Entry
18 of Order with the Arizona State Board of Pharmacy admitting that factual allegations contained in the
19 Notice of Hearing Number 00-0017-PHR are true and accurate.

20 3. That KIEL T. GILLETTE admits to violations of A.A.C. § R4-23-204(D)(1) to wit:
21 failure to produce original certificates verifying participation in 30 hours of Continuing Education for the
22 period November 1, 1997 to October 31, 1999 as required for renewal of Certificate of Registration
23 Number 9347 pursuant to A.R.S. § 32-1936.

24 4. That KIEL T. GILLETTE is aware of the fact that the conduct contained in the factual
25 allegations constitutes grounds for disciplinary action as provided for in A.R.S. § 32-1927(A)(10).

1 CONCLUSIONS OF LAW

4 1. The Board concludes that it has jurisdiction in this Matter pursuant to A.R.S. § 32-1927
5 (A)(10) and 32-1925(G)(2). The Board concludes that KIEL T. GILLETTE did violate A.A.C. §
6 R4-23-204 (D)(1) to wit: failure to produce original certificates verifying participation in 30 hours of
7 Approved Continuing Education for the period November 1, 1997 to October 31, 1999 as required for
8 the renewal of Certificate of Registration Number 9347 on October 31, 1999, pursuant to A.R.S. §
9 32-1936.

10 2. The Board further concludes that KIEL T. GILLETTE is in violation of A.R.S. § 32-
11 1927(A)(10).

12 ORDER

13 III

14 The certificate of Registration Number 9347 issued to KIEL T. GILLETTE is placed on
15 probation for one year commencing ten (10) days from the date of this Order. The probation may be
16 terminated subject to the following conditions:

17 1. KIEL T. GILLETTE shall pay a one-hundred (\$100.00) civil penalty to the Board within 60
18 days of the date of the Order.


19 2. KIEL T. GILLETTE shall complete thirty-six (36) hours of ACPE Approved Continuing
20 Education within one (1) year of the date of this Order. Said hours shall apply only to the failure on
21 this Order and shall not be applied to subsequent renewals.

22 3. KIEL T. GILLETTE shall pay all fees and complete all Continuing Education requirements
23 throughout the term of probation to maintain Certificate of Registration Number 9347.

24 4. KIEL T. GILLETTE shall obey all the laws and rules governing the practice of pharmacy.

25 5. The probation shall be terminated upon receipt of satisfactory evidence by the Board staff
26 of completion of the conditions outlined in paragraphs (1.) and (2.) above.
