10 Pursuant to the foregoing Consent to Entry of Order, the evidence and records compiled and
11 contained in the file for JAIME CASILLAS and for good cause appearing, the Board on this 6th day of
12 September, 2001 enters the following Finding of Fact, Conclusions of Law and Board Order in the Matter
13 of 01-0014-PHR.

14 **FINDINGS OF FACT**

15 **I**

16 1. JAIME CASILLAS is the holder of Pharmacist License Number 3261 issued by the Arizona
17 State Board of Pharmacy which permits the holder to practice pharmacy in the State of Arizona.

18 2. That on the 22nd day of AUGUST, 2001 JAIME CASILLAS entered into a Consent to Entry
19 of Order with the Arizona State Board of Pharmacy admitting that factual allegations contained in the
20 Notice of Hearing Number 01-0014-PHR are true and accurate.

21 3. That JAIME CASILLAS admits to violations of A.R.S. § 32-1927(A)(10), and A.R.S. § 32-
22 1927(B)(1) to wit:

23 32-1927(A)(10) The licensee is found by the Board to be guilty of violating any Arizona or
24 federal law, rule or regulation relating to the manufacture and distribution of drugs, and devices
25 or the practice of pharmacy.

26 32-1927 (B)(1)The licensee is found by the Board to be guilty of dispensing a different drug or
brand of drug ordered or prescribed without the express permission in each case of the orderer,
or in the case of a prescription order, the medical practitioner. The conduct prohibited by this
paragraph does not apply to substitutions authorized pursuant to A.R.S. § 32-1963.01.

1 CONCLUSIONS OF LAW

2 II

3 1. The Board concludes that it has jurisdiction in this Matter pursuant to A.R.S. § 32-1927(A)(10)
4 and A.R.S. § 32-1927(B)(1).

5 2. The Board concludes that JAIME CASILLAS violated A.R.S. § 32-1927(A)(10), and A.R.S.
6 § 32-1927(B)(1).

7 ORDER

8 III

9 The Pharmacist License Number 3261 issued to JAIME CASILLAS is hereby placed on
10 probation for (1) year. The probation is subject to the following conditions:

11 1. JAIME CASILLAS shall pay a civil penalty of one thousand dollars (\$1000.00) to the Board
12 by December 31, 2001.

13 2. JAIME CASILLAS shall pay all fees and complete all Continuing Education requirements
14 throughout the term of probation to maintain Pharmacist License Number 3261.

15 3. JAIME CASILLAS shall obey all federal and state laws and rules governing the practice of
16 pharmacy.

17 4. JAIME CASILLAS shall not serve as a pharmacist in charge or preceptor pharmacist
18 throughout the term of probation.


19 5. If JAIME CASILLAS violates this Order in any way or fails to fulfill the requirements of this
20 Order, the Board, after giving the Respondent Notice and the opportunity to be heard, may revoke,
21 suspend or take other disciplinary action against the Respondent. The issue at such hearing will be limited
22 solely to whether this Board Order has been violated.
