9 the following Finding of Fact, Conclusions of Law and Board Order in the  
10 Matter of 91-14-H.

11 FINDINGS OF FACT

12 I

13 1. A. BRADLEY HOTZ is the holder of Certificate of Registration Number  
14 7289 issued by the Arizona State Board of Pharmacy which permits the holder  
15 to practice pharmacy in the State of Arizona.

16 2. That on the 22nd day of July, 1991 A. BRADLEY HOTZ did enter into  
17 a Consent to Entry of Order with the Arizona State Board of Pharmacy admitting  
18 that the factual allegations contained in Notice of Hearing Number 91-14-H are  
19 true and accurate.

20 3. That A. BRADLEY HOTZ admits to violations of A.R.S. § 32-1968, A.R.S. §  
21 36-2525 and C.F.R. § 1306.21 to wit: dispensing prescription only medications  
22 and Controlled Substances without the proper order of a licensed practitioner  
23 on multiple occasions.



1 4. A. BRADLEY HOTZ may appear before the Arizona State Board of Pharmacy on  
2 or after January 2, 1992 to show cause why the probation placed on Certificate  
3 of Registration Number 7289 be terminated prior to the completion of one (1)  
4 year.

5 5. If the Respondent violates this Order in any way or fails to fulfill  
6 the requirements of this Order, the Board, after giving the Respondent Notice  
7 and the opportunity to be heard, may revoke, suspend or take other disciplinary  
8 action against the Respondent.
