7 This Matter came before the Arizona State Board of Pharmacy
8 on the 20th day of January, 1994 pursuant to a request by the
9 Respondent, petitioning the Arizona State Board of Pharmacy to stay
10 the suspension imposed in the Matter of 94-01-H dated the 20th day
11 of January, 1994. Michael Noel, president, presided with members
12 Gerald G. Ritt, Kathryn L. Kalsman, Perry D. Don and John L.
13 Harrington Jr. in attendance and participating therein.

14 After consideration of the request and testimony as to the
15 compliance with requirements of the Pharmacists Assisting
16 Pharmacists of Arizona Program on the part of the Respondent, the
17 Board agreed to stay the suspension and impose probation continuing
18 at least until the 19th day of January, 1999, thereby amending the
19 Order imposed in the Matter of 94-01-H.

1 2. **JAMES J. GREEN** shall submit to a minimum of twenty-four
2 (24) random biological fluid screenings for the presence of drugs
3 or alcohol in the system per year and at times to be determined by
4 the Pharmacists Assisting Pharmacists of Arizona or other board
5 approved program the first twenty-four (24) months of the probation
6 period.

7 3. **JAMES J. GREEN** shall not serve as a preceptor pharmacist
8 nor as a Pharmacist in Charge throughout the term of probation.

9 4. **JAMES J. GREEN** shall take and successfully complete the
10 Arizona Jurisprudence Examination (AZPLEX) with a score of 90% or
11 better within 120 days of the date of this Order.

12 5. In lieu of a civil penalty in this Matter, **JAMES J. GREEN**
13 is required to perform 200 hours of community service in a Board
14 approved program during the time of probation and shall further
15 submit evidence of those hours to the Arizona State Board of
16 Pharmacy prior to January 19, 1999.

17 6. **JAMES J. GREEN** shall furnish the Arizona State Board of
18 Pharmacy with a list of all jurisdictions in which he maintains or
19 has maintained licensure in the profession of pharmacy along with
20 the registration number of said licenses.

21 7. **JAMES J. GREEN** is required to advise the Arizona State
22 Board of Pharmacy immediately of any change in pharmacy employment
23 status throughout the term of probation.

24 8. **JAMES J. GREEN** shall pay all fees and complete all
25 Continuing Education requirements to maintain certificate of
26

1 registration number 5337 throughout the term of probation.

2 9. JAMES J. GREEN shall obey all federal and state laws and
3 rules governing the practice of pharmacy.

4 10. JAMES J. GREEN shall bear the responsibility for the
5 release of information forms and reports required by this Order.

6 11. JAMES J. GREEN shall bear all costs for testing,
7 rehabilitation, aftercare programs and reports to be filed.

8 12. JAMES J. GREEN shall "hold harmless" the provider of any
9 required reports to the Board of Pharmacy.

10 13. JAMES J. GREEN shall appear before the Arizona State
11 Board of Pharmacy on or after the 19th day of January, 1999 to show
12 cause why the probation imposed in this matter should be removed.

13 14. If JAMES J. GREEN violates this Order in any way or fails
14 to fulfill the requirements of this Order, the Board, after giving
15 the Respondent Notice and the opportunity to be heard, may revoke,
16 suspend or take other disciplinary action against the Respondent.




