10 Pursuant to the foregoing Consent to Entry of Order, the evidence
11 and records compiled and contained in the file for AARON DAVID CUKIER
12 and for good cause appearing, the Board on this 18th day of April,
13 1996 enters the following Finding of Fact, Conclusions of Law and
14 Board Order in the Matter of 95-28-H.

14 FINDINGS OF FACT

15 I

16 1. AARON DAVID CUKIER is the holder of Certificate of
17 Registration Number 5878 issued by the Arizona State Board of Pharmacy
18 which permits the holder to practice pharmacy in the State of Arizona.

19 2. That on the 13th day of November, 1995, AARON DAVID CUKIER did
20 enter into a Consent to Entry of Order with the Arizona State Board of
21 Pharmacy admitting that factual allegations contained in the Notice of
22 Hearing Number 95-28-H are true and accurate.

23 3. That AARON DAVID CUKIER admits to violations of A.R.S. §
24 32-1927(A)(2) and A.R.S. § 32-1927(b)(3)(e) to wit:

25 A. Admitted to the offense of Facilitation of
26 Fraudulent Schemes, a Class 6 Felony conviction.

1 2. AARON DAVID CUKIER shall not serve as a pharmacy
2 preceptor for a period of one (1) year effective January 1 through
3 December 31, 1996.

4 3. AARON DAVID CUKIER shall take and successfully complete the
5 Arizona Jurisprudence examination (AZPLEX) with a score of 90% within
6 120 days of the date of this Order.

7 4. AARON DAVID CUKIER shall perform three hundred (300) hours of
8 community service in a program approved by the Board or its designee.
9 A verified report of these hours shall be delivered to the Board or
10 its designee on or before November 26, 2000.

11 5. AARON DAVID CUKIER shall pay all fees and complete all
12 Continuing Education requirements throughout the term of probation to
13 maintain Certificate of Registration Number 5878.

14 6. AARON DAVID CUKIER shall obey all the laws and rules
15 governing the practice of pharmacy.

16 7. AARON DAVID CUKIER shall appear before the Arizona State
17 Board of Pharmacy to request the removal of probation on or after
18 November 26, 2000.

19 8. If AARON DAVID CUKIER violates this Order in any way or fails
20 to fulfill the requirements of this Order, the Board, after giving the
21 Respondent Notice and the opportunity to be heard, may revoke, suspend
22 or take other disciplinary action against the Respondent.
