16 1. ROBERT A. CLAYTON is the holder of Certificate of Registration  
17 Number 5071 issued by the Arizona State Board of Pharmacy which  
18 permits the holder to practice pharmacy in the State of Arizona.

19 2. That on the 12<sup>th</sup> day of February, 1999, ROBERT A. CLAYTON did  
20 enter into a Consent to Entry of Order with the Arizona State Board of  
21 Pharmacy admitting that factual allegations contained in the Notice of  
22 Hearing Number 99-0004-PHR are true and accurate.

23 3. That ROBERT A. CLAYTON admits to violations of A.R.S. §  
24 32-1927(A)(10), and A.R.S. § 32-1927(B)(1) to wit:

25 1. The licensee is found by the Board to be guilty of violating  
26 any Arizona or federal law, rule or regulation relating to the  
manufacture and distribution of drugs, and devices or the practice of  
pharmacy.
